19 **DECLARATION**

20 I, David Koenig, declare the following under penalty of perjury:

- 21 1. This declaration sets forth facts as would be admissible in evidence, and I am competent
- 22 to testify to the matters stated.
- 23 2. I have competed in Scrabble tournaments since November 9th, 2002 and I have won cash
- 24 prizes in many of these events.
- 25 3. The vast majority of these events have been sanctioned by the National Scrabble
- 26 Association (NSA) in the USA and Canada through June 2009, by the North American
- 27 Scrabble Players Association (NASPA) in the USA and Canada from July 2009 onward,
- 28 by the Association of British Scrabble Players (ABSP) in the UK and Europe.
- 29 4. Additionally, many of these tournaments have been sanctioned by the World
- 30 English-language Scrabble Players Association (WESPA), and I have played in a small

- 1 number of tournaments which were sanctioned only by WESPA and not by one of the
2 other associations.
- 3 5. I have won prize money in United States Dollars, Canadian Dollars, British Pounds,
4 Euros, and Malaysian Ringgit.
- 5 6. All Canadian prize winnings are estimates in American Dollars, as I do not have exact
6 data for those tournaments.
- 7 7. I have made a good faith effort to collect all data that I could on past prize winnings, but
8 the data sources are incomplete.
- 9 8. I have made a good faith effort to estimate all unknown prizes as accurately as possible.
- 10 9. My data for NSA and NASPA tournaments comes from cross-tables.com. The **Prize**
11 column in the first chart corresponds to the data at
12 <https://www.cross-tables.com/results.php?playerid=60>, except as noted in the next item.
- 13 10. I have added to the **Prize** column two prizes, because I have corroborated exact values
14 for those prizes. They are for the 06/07/14 tournament in Pittsburgh and the 12/08/17
15 California Open.
- 16 11. Where cross-tables has provided estimates, I have used their estimates.
- 17 12. The rows highlighted in yellow are tournaments in which I likely won money but for
18 which cross-tables has no data.
- 19 13. I have estimated my likely winnings at the tournaments in yellow, using several heuristics
20 as a guide:
- 21 a. Comparison to other tournaments with roughly the same size of field and a similar
22 result.

- 1 b. Multiday tournaments (more than 8 rounds) tend to pay higher than one-day
2 tournaments (8 rounds or fewer).
- 3 c. Anecdotal knowledge of particular directors and geographic areas that tend to pay
4 higher or lower prizes.
- 5 d. Knowledge of specific events that is not from official data sources is noted.
- 6 14. The second chart shows all of my winnings from ABSP tournaments. Stewart Houtens of
7 ABSP provided me the full list of ABSP tournaments that I played.
- 8 15. The vast majority of the ABSP prize winnings are corroborated by ABSP data or by my
9 own social media posts, as shown in the notes.
- 10 16. The third chart shows the only tournaments that I am aware of which were sanctioned by
11 WESPA but not by NSA, NASPA, or ABSP in which I won prizes.
- 12 17. The links in the third chart show corroboration of those finishes, but I have not found any
13 extant data corroborating the prize amounts.
- 14 18. For ABSP and WESPA tournaments where I do not have data, I have estimated from
15 memory.
- 16 19. The fourth chart combines the totals of the previous three charts to estimate my total
17 prize winnings in American dollars.
- 18 20. I have not accounted for the changing relative value of the currencies and have just used a
19 fixed estimate of \$1.30 to a Pound, \$1.10 to a Euro, and \$0.22 to a Ringgit.
- 20 21. The value in US Dollars of the total estimated prize winnings I have calculated is
21 \$21,602.

- 1 22. Although the estimate for an individual tournament might be slightly higher or lower than
2 what I actually won, I believe this total number is a good ballpark estimate for how much
3 money I have won in place or class prizes at these tournaments.
- 4 23. I also believe that this number underestimates my total winnings from Scrabble
5 tournaments for two reasons:
- 6 a. I sometimes won high game or high word prizes for individual games or plays
7 that are not always accounted for in this data.
 - 8 b. I played in a few unsanctioned house tournaments and may have won money in
9 some of those. Since I do not have data about these nor good memory of the
10 specifics, I have omitted them from consideration in these calculations.
- 11 24. These prize winnings encompass a roughly 20 year period, from late 2002 to early 2022.
- 12 25. Combining the conclusions of items 21 and 24, I have won on average a little more than
13 \$1000 per year over the course of my entire tournament Scrabble career.
- 14 26. Inspection of the chart of NASPA events shows that my winnings are heavily biased
15 toward the more recent years. I have more consistently won prizes, and many of the
16 prizes that I have won have been bigger in the later part of the chart.
- 17 27. Note, for example, that I won money in every single tournament between November
18 2017 and October 2019.
- 19 28. Almost all of the international prize winnings in the ABSP and WESPA charts are from
20 2016 and later.
- 21 29. Based on the factors in items 26-28, I think it is a reasonable estimate that my expected
22 prize winnings in recent years would have been in the range of \$1500-\$2000 per year, if
23 the defendants had not interfered with my ability to compete in Scrabble tournaments.

1 30. This \$1500-\$2000 per year estimate is consistent with the statement I made in item 7 of
2 my affidavit on May 22, 2023.


