Thank you again for the opportunity to respond.

In addition to reiterating my statements regarding the protective order and the other allegations in Mr. Koenig's original ethics complaint letter, I contest the following assertions in Mr. Koenig's ethics complaint follow-up letter.

It is not true that "[t]he protective order is exactly what enabled Mr. Fuller to paint a false picture" in my head. First, based on Mr. Koenig's previous behavior and statements to me, I had no reason whatsoever to assume that the accusations in Mr. Fuller's letter were false or unreasonable. Second, the existence of the protective order had no effect on my judgment in this matter. I repeatedly advised Mr. Koenig not to make public statements or contact potential witnesses or interested parties, without success.

I do not share Mr. Koenig's characterization of our conversation on July 10. While I attempted to be equanimous rather than accusatory toward him, I did not express embarrassment or indicate that I did not understand the adversarial relationship between plaintiff's and defendants' counsel in litigation. What I attempted to express was my sense that Mr. Koenig wanted an attorney who was willing to exceed, in my judgment, the boundaries of that legitimately adversarial relationship, and that I was not that attorney. As noted in my communication with Mr. Koenig, I strongly advised him, based on what I had learned, that it was in his best interest to voluntarily dismiss the claims against the defendants. He chose not to do so.

Regarding Mr. Koenig's complaint that he was not provided with copies of every filing that was made in the case, there is nothing in ORPC Rule 1.4 that requires, or even suggests, that an attorney has a duty to provide a client with every document created over the course of litigation. I kept Mr. Koenig reasonably informed about the status of his case, provided information promptly when it was requested, and explained matters such that Mr. Koenig could make reasonably informed decisions about his case, as is demonstrated by the documentation he has submitted with his complaint.
